

Free MT4 and MT5 VPS Terms and Conditions

v.3 August 2021



Axiance, a trade name operated by Aerarium Limited (hereinafter the "Axiance" or "Company"), offers the following "Free MT4 and MT5 VPS" (hereinafter the "MT4 and MT5 VPS" or "VPS") to its Clients subject to the Terms and Conditions contained herein.

Aerarium Limited in this promotion is offering MT4 and MT5 VPS (Virtual Private Server) hosting as long as the Clients meet the requirements set in these terms and conditions.

- 1. By opening a trading account under this MT4 and MT5 VPS Service Program the Client acknowledges that he has read, and agreed to be bound by, these terms and conditions as well as to the Aerarium Limited Trading Terms and Conditions.
- 2. Furthermore, the Client acknowledges that Aerarium Limited provides the VPS Service Program via services rendered through Fozzy Inc. ("the Service Provider") in accordance to the terms and conditions as specified at Clause 2 above and/or in accordance to the Service Provider Terms and Conditions.
- 3. The Client acknowledges that he has read and agreed to be bound by, the Service Provider Terms and Conditions.
- 4. For a new Client to be eligible to obtain a FREE MT4 and MT5 VPS service should deposit a minimum of USD 5,000 or equivalent in total in his trading account(s). An existing Client to be eligible to obtain a FREE MT4 and MT5 VPS service should maintain a combined balance of USD 5,000 or equivalent in his trading account(s).
- 5. For a Client to be able to continue receiving the MT4 and MT5 VPS service for FREE should meet the following criteria:
 - a) Maintain a combined balance of USD 5,000 or equivalent in his trading account(s) on the last calendar day for every month; and
 - b) At least complete a minimum monthly trading volume of 5 lots
- 6. If a Client is not meeting the above 2 criteria as specified in clause 5, Aerarium Limited has the right to remove the VPS service OR in case the Client wishes to continue benefitting from the VPS service then the Client should cover the fee of USD 20 / EUR 20 for covering the VPS cost. The Client acknowledges and agrees that the fee of USD 20 / EUR 20 will be automatically deducted from the Client's trading account.



- 7. If a Client does not meet the requirements listed on clause 5 and would like to get the VPS service, then a fee of USD 20 / EUR 20 may apply. The Client acknowledges and agrees that the fee of USD 20 / EUR 20 will be automatically deducted from the Client's trading account.
- 8. The Client agrees and acknowledges that Aerarium Limited is not responsible for any power or technical failures or any disconnection of the MT4 and/or MT5 found on the VPS; this is a sole responsibility of the Client. In addition, the Client acknowledges that the VPS hosting is controlled by the Service Provider and Aerarium Limited shall not be liable for any possible error or breakdown of the hosting service including, but not limited to, any communication/data failure, system errors, etc.
- 9. The Client agrees and acknowledges that Aerarium Limited does not provide any guarantee of the data/application etc. that is kept on the VPS and that Aerarium Limited does not conduct any backups or provides any service to safeguard any data/information held on the VPS.

*VPS fee is USD 20 / EUR 20 - depending on the account currency, that the VPS was granted for. In case the account currency is different from EUR / USD – the equivalent of 20 USD will be deducted, based on that day's exchange rate.

- 10. The Client agrees and acknowledges that VPS is the sole responsibility of the Client and that the Client should take all necessary measures to secure and backup their own data/applications.
- 11. The Client agrees and acknowledges that Aerarium Limited will only remedy faulty VPS systems by recreating the VPS i.e. "fresh install", as initially provided by Aerarium Limited with just the operating system and no other Client added data or applications.
- 12. The FREE VPS service is available on a per client basis.
- 13. If Aerarium Limited suspects that a Client has abused or attempted to abuse this promotion or otherwise acted with a lack of good faith towards Aerarium Limited, then Aerarium Limited reserves the right, at its sole discretion, to deny, withhold or withdraw from the Client his eligibility of participating in the VPS service or promotion, even in cases where the Client



meets the conditions set on above clauses, and if necessary to cancel any terms and conditions with respect to that Client, either temporarily or permanently, or terminate that Client's access to the service and/or block that Client's account.

- 14. To apply for the VPS service, the Client needs to send an email via his registered email address to support@axianceint.com stating his trading account number.
- 15. Aerarium Limited reserves the right to modify, change or terminate this promotion/offer at any time without the consent of the Client.
- 16. Clients will be excluded from this promotion in case they abuse the program and withdraw funds with the purpose to redeposit them again in order to participate in the said promotion. The Deposits should be fresh funds deposited by the Client.

The Company does not offer Contracts for Difference ("CFDs") to residents of certain jurisdictions as these are listed on the Company's website such as the Belgium, Canada, Cyprus, Cuba, Israel, Latvia, Lithuania, North Korea, Seychelles, Syria, Sudan, United States of America, Ukraine and Venezuela.
